HUNTING PROGRAM VIOLATIONS OR OFFENSES FOR WHICH PRIVILEGES ARE SUSPENDED OR REVOKED

The following identifies a guideline of administrative penalties that will be imposed for violations of Camp Bullis natural resource and hunting policies*. Each case will be analyzed on a case-by case basis and depending on facts and circumstances; administrative penalties may be adjusted downward or upward from these guidelines.

Suspension of privileges will be for all scouting and hunting activities during the suspension period regardless of what season the violation was committed. These are administrative penalties will be assessed separate from any legal violations of Federal, State, or Local Laws.

Suspensions take effect the date the violation is noted and continues according to the following times: 2 weeks = 15 days, 6 months = 182 days, 1 year = 365 days, 2 years = 730 days, 5 years = 1,826 days, 10 years=3,652 days, and Lifetime = the fullest extent of the individual's natural life.

*Multiple violations at one time will be aggregative and may result in longer suspensions than all individual suspensions combined. Subsequent violations of the JBSA Hunting Regulations after the first offense may also result in longer suspensions.
